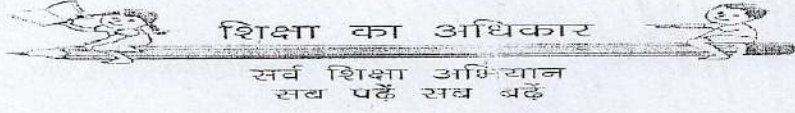

**NOTIFICATION.**

Whereas, the Hon'ble Supreme Court while disposing of the Writ Petition (c) No. 147 of 2014, filed by Naz Foundation (India ) Trust Vrs Union of India & Ors , has passed an order dated 31.03.2017 directing all States / Union Territories to consider issuing appropriate individual notification (s) to bring children living with or affected by HIV within the definition of "Child Belonging to Disadvantaged Group" as defined under Section 2 (d) of the Right of children to Free and Compulsory Education Act. 2009;

Whereas, the Government of Arunachal Pradesh considered the matter and decided to issue notification so as to include children living with or affected by HIV, within the definition of child belonging to " disadvantaged group " under Section 2 (d) of the Right of Children to Free and Compulsory Education Act, 2009;

And therefore, it is ordered that (a)the HIV affected children/ their parents/ Head Teachers/ Headmasters/ Principals of the schools where the affected children are admitted / studying, may submit their names to the DDSE / DPO , who shall forward the names to the State Project Director SSA Rajya Mission, Itanagar for inclusion as child / children belonging to " disadvantaged group " .

(b) The children living with or affected by HIV shall have to obtain medical certificate from the competent medical authority (s) to enable him /her to be considered as "child belonging to disadvantaged group"

This notification shall come into force with immediate effect.

In compliance of the office memorandum No. MAIDS No.-ARTC/I/2009 Dated Naharlagun the 30<sup>th</sup> May/2017 issued by the Director of Health Services, I Have attended the State Grievance Redressal Committee (SGRC) meeting for PLHAs on 8<sup>th</sup> June/2017 at the office chamber of the SPI Secretary (H&FW) Govt. of Arunachal Pradesh, Itanagar.

The following were the issues that were decided to be attended by the Department of Food & Civil Supplies:-

1. While appreciating the initiative of the Department of Food & Civil Supplies for appraising GOI to allocate additional AAY beneficiaries Quota for accommodating PLHAs of Arunachal Pradesh, the committee was of the opinion that the Department of Food & Civil Supplies may remind the GOI again for allocation of additional AAY quota for Arunachal Pradesh for accommodating PLHAs under AAY scheme.

2. The committee also were of the opinion that the Department of Food & Civil Supplies may also explore possibilities to accommodate the PLHAs in PHH scheme which may be converted to AAY scheme when GOI consider allocation of additional AAY quota for the purpose of accommodating PLHAs in the State.


