MESSAGE FROM THE DESK OF PATRON

Dear Readers,

A warm welcome to NACO news for the last quarter of 2021. Needless to say, the quarter has been very eventful with observance of the World AIDS Day and the launch of 3rd phase of New India@75.

NACO observed the 34th World AIDS Day on 1st December, 2021. Dr. Bharati Pravin Pawar, Hon'ble Minister of State, Health & Family Welfare graced the occasion as Chief Guest. Aligning with the theme of World AIDS Day 2021 "End Inequalities. End AIDS. End Pandemics", the Union Minister of State for Health & Family Welfare emphasized on the need to focus and tackle gender inequalities, discrimination against the high-risk groups, inequalities in voice, income inequality and work on to provide social protection to the infected and affected population. She mentioned, "For ensuring Jan Swasthya, it's important to collate our efforts in a strategic manner for achieving our goals by leaving no one behind as desired by Sustainable Development Goals".



We are now more than 2 years into the COVID-19 pandemic and the contexts of public health programmes have changed beyond believes and imagination. Despite the challenges, the facilities under the National AIDS Control Programme (NACP) continued to provide HIV related services. Supply chain for key test kits, medicines and commodities have remained uninterrupted. Comprehensive care of people living with HIV is not only maintained but further augmented too. In the first six months of 2021-22, the programme has reached almost 50 lakh of high-risk and vulnerable population with a comprehensive package of targeted, peer-led prevention services through revamped interventions. In the same period, more than 2.25 crore of HIV tests have been undertaken among high-risk groups, other vulnerable populations, and pregnant women. Given the trend, we anticipate that the programme would cover more than a crore high-risk and vulnerable population with a comprehensive package of peer-led prevention services and undertake more than 4.5 crore HIV tests. These achievements are at-par with the progress during 2019-20.

Despite the remarkable progress in the National AIDS response, there is no place of complacency. The country is on-track to attain 90% reductions in annual new HIV infections and AIDS-related deaths by 2030, as committed under Sustainable Development Goals. 'Break the silos: Build Synergies' would be the mantra for optimized yet augmented AIDS response for NACP.

With this, I urge readers to keep following COVID-19 appropriate behavior and help us overcome this situation. Stay Safe.

As 2021 draws to a close, we commit ourselves to continue to work for the benefit of the High Risk Groups and the people infected and affected by HIV/AIDS.

This year's World AIDS Day 2021 event was observed on 1st December, 2021 at Dr. Ambedkar International Centre, New Delhi which was graced by the presence of Hon'ble Minister of State, Health & Family Welfare; Secretary, Health & Family Welfare and senior officials from NACO, representatives of development partners and community representatives.

Another important workshop to build the capacity of the State teams to strengthen Advocacy, Mainstreaming efforts in NACP and upscale Social Protection at the States/UTs was also organized on 16th & 17th December, 2021 at New Delhi. The workshop provided an opportunity for the participants to learn the newer approaches adopted by the States in building synergies with the departments in promoting NACP services and social protection for the people infected and affected by HIV/AIDS.

Health is vital for improved developmental outcomes. From an economic standpoint, better health improves productivity and reduces losses due to premature death, prolonged disability and early retirement. 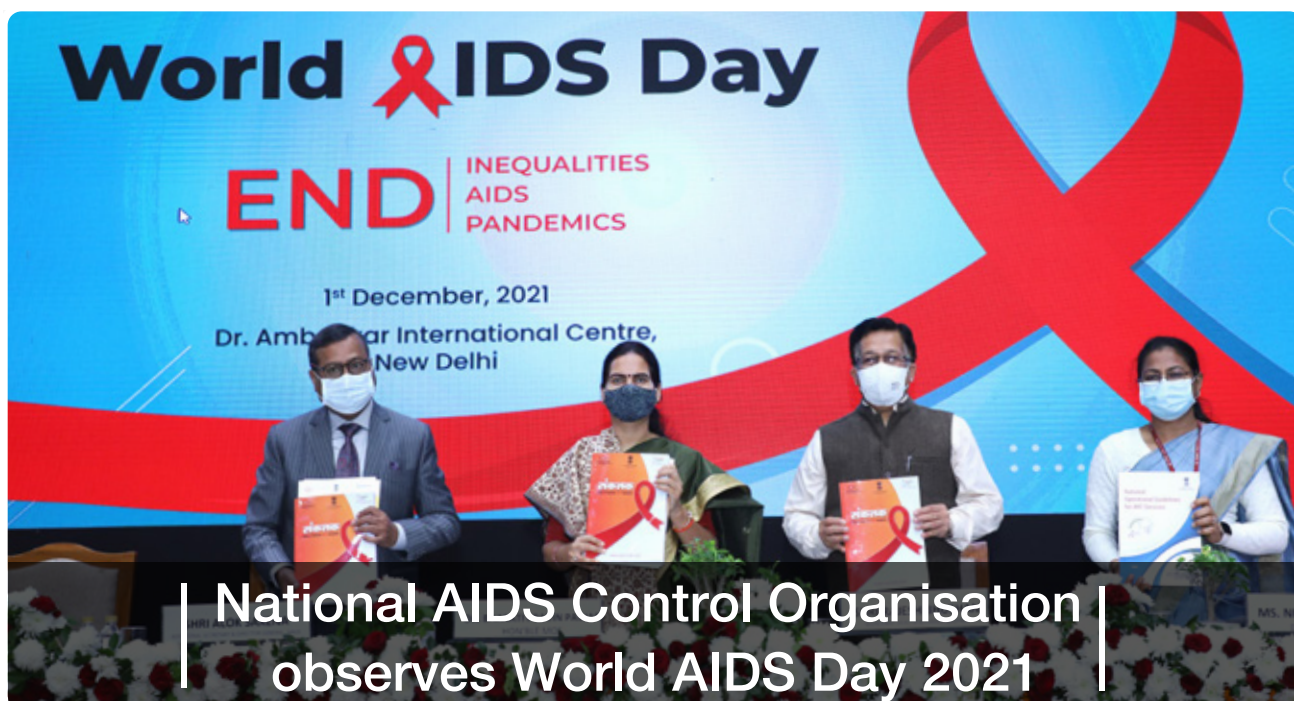

National AIDS Control Organisation observes World AIDS Day 2021

Every year, NACO organizes a National level event to commemorate the World AIDS Day with participation of communities, development partners and Delhi State AIDS Control Society (DSACS). This year, the event was organized at the Dr. Ambedkar International Centre, New Delhi. The event was graced by the presence of Dr. Bharati Pravin Pawar, Hon'ble Minister of State, Health & Family Welfare. The event was also attended by Shri Rajesh Bhushan, Secretary, Health & Family Welfare; Shri Alok Saxena, Additional Secretary and Director General, NACO; Ms. Nidhi Kesarwani, Director, NACO and stakeholders.

Aligning with the theme of the **World AIDS Day 2021 "End Inequalities. End AIDS. End Pandemics"**, the event emphasized on the need to focus and tackle gender inequalities, discrimination against the High-Risk Groups, inequalities in voice, income inequality and work on to provide Social Protection to the infected and affected population. The event was also attended by students of Red Ribbon Clubs from the States of Assam, Bihar, Chhattisgarh, Goa and Rajasthan and interacted with Hon'ble Minister of State, Health & Family Welfare and with the Secretary, Health & Family Welfare.

Dr. Bharati Pravin Pawar, Hon'ble Minister of State, Health & Family Welfare appreciated the efforts of NACO and involvement of the communities, Civil Society Organizations and development partners in India's fight against HIV and AIDS. She had also shared her experience as a medical practitioner with the people infected with HIV/AIDS. Various publications of NACO were released by the Hon'ble Minister. These are as follows:

- National Operational Guidelines for ART Services 2021
- National Guidelines on HIV Care and Treatment 2021
- National Technical Guidelines on Pre-Exposure Prophylaxis
- Sankalak 3rd Edition 2021 & India HIV Estimates 2020
- District Level HIV Estimates & prioritization in India 2019

Addressing the event, the Union Health Secretary, Shri Rajesh Bhushan emphasized on the fact that inequalities and diseases are interlinked as reduction in inequalities gives rise to access to healthcare services and improves the overall standard of lives of people. Shri Alok Saxena, AS & DG, NACO mentioned that the National AIDS Control Programme has covered a long journey. More than 34,000 testing centers, 1900 Anti-Retroviral Treatment Centres and 1400 targeted interventions are currently running in the country, which are providing services to People Living with HIV and more than 4 million high-risk groups and target populations. Ms. Nidhi Kesarwani, Director, NACO reiterated NACO's commitment towards increasing HIV awareness, speak out against HIV stigma, and call for an integrated and enhanced response towards attainment of ending the AIDS epidemic as a public health threat by 2030 as committed under Sustainable Development Goals. Officials from the Ministry of Health and Family Welfare, dignitaries from development partners and community representatives were also present in the meeting.

The event of World AIDS Day was commenced with flagging off an IEC Van by Ms. Hema Sardesai, a well known playback singer, lyricist and Social Activist. A Bharatnatyam recital was also presented by Ms. Sapna Naik along with

RRC students of Kala Academy. On the occasion, the News bulletin of Goa SACS was released. A month-long campaign was conducted to create awareness on HIV/AIDS through the IEC van.



World AIDS Day 2021 was observed by Uttarakhand SACS at Dehradun. The event was graced by the presence of Hon'ble Minister of Health of Uttarakhand as Chief Guest. During the event, Doctors, Counselors, Lab Technicians of ICTC, STI Clinics, OST Centers, ART Centers, TI NGOs & staff of ICTC mobile van were felicitated

for their excellent work in the HIV/AIDS Programme. Staff of USACS, representatives from TI NGOs, Government Departments, Private Organizations, Industries under Employee Led Model and Students of NSS Uttarakhand attended the event.



On 1st December, 2021 Gujarat SACS along with Rajkot Municipal Corporation organized World AIDS Day at Rajkot. Shri Ashish Kumar, IAS, Deputy Commissioner, Rajkot Municipal Corporation flagged off a rally to commemorate

the occasion. During the meeting various organisation were felicitated to acknowledge their services during the COVID-19 pandemic period at Rajkot.



Andaman & Nicobar AIDS Control Society

ANACS organized an event at Dr. B R Ambedkar auditorium, PBMC, Port Blair to observe World AIDS Day, 2021. Various other activities like Rally, Painting competition, Quiz competition, Essay competition, Speech competition and Awareness Programme on HIV/AIDS were conducted during the event. 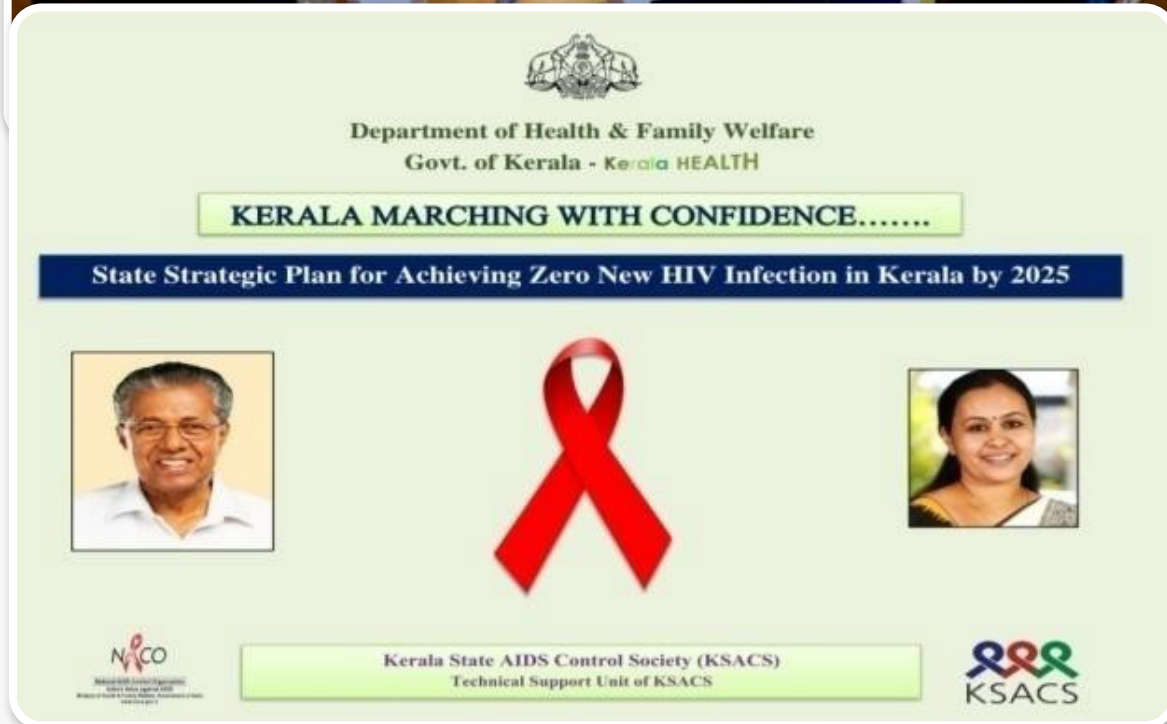

Sikkim SACS

National Review Meeting of Care, Support and Treatment Services

The Care, Support and Treatment (CST) division of NACO conducted the annual review meeting of SACS in Visakhapatnam. The objective of this meeting was to review the progress made in the CST programme with focus on new strategies adopted in the last two years. The three-day review provided a platform to share the innovations and

best practices adopted by various States. Respective State representatives presented about available CST services, progress towards 95-95-95, treatment cascade, attrition indicators, viral load cascade, budget utilization, and challenges with proposed action plans.



Visit of AS & DG, NACO to the One-Stop Centre established for Transgender Community

A high-level delegation headed by **Shri. Alok Saxena, Additional Secretary and Director General, NACO** visited the **One-Stop Centre (OSC)** established for Transgender Community at King George Hospital in Visakhapatnam on **12th November, 2021**.

Shri Alok Saxena, AS & DG, NACO interacted with the technical team of Project ASPIRE and transgender community on the experiences of One Stop Center and appraised for timely effort of mainstreaming a niche medical requirement.



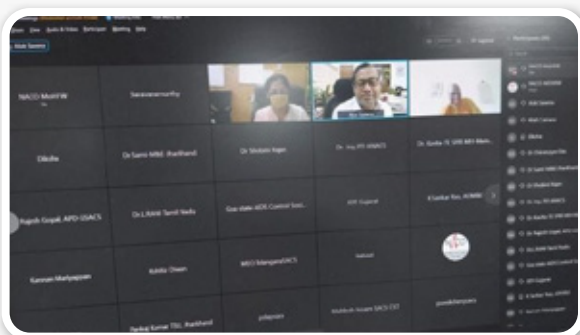
He advised to establish similar centres in other government facilities to cater the transgender people-specific health needs in Andhra Pradesh. The team also interacted with the members of transgender community and the Hijra Nayaks. To maximise the efforts and to further ensure

sustainability, the project is coordinating with targeted intervention NGOs and district level structures including DAPCU and Community Advisory Board in improving access and acceptability of HIV services for transgender population.

Brown Bag Seminar Series - A Cross Institutional Collaboration

National AIDS Control Organisation undertakes various activities as part of its capacity building initiatives. As part of the series, a talk was held on **“Reflections on the HIV Programme in the country and way forward to achieving the SDG Goals of 2030”** by Dr Bilali Camara, Medical Epidemiologist, UNAIDS Awardee for Human Rights under the chairmanship of Shri Alok Saxena, AS&DG, NACO.

The other talk was held on “Migration and Epidemics” by Prof. Chinmay Tumbe, Asst. Professor, Economics Area, Indian Institute of Management, Ahmedabad. The talk was attended by Smt. Arti Ahuja, Additional Secretary (Health), Senior officers, Programme managers from NACO, Senior Officials from State AIDS Control Societies and Technical Support Units, Experts, Academicians, Researchers, Development and Implementing Partners, Civil Society and Community representatives.



Release of documentary - ‘Mitr Clinic - Pride and Beyond’



Shri Alok Saxena, AS & DG NACO inaugurated the screening documentary on **‘Mitr Clinic – Pride and Beyond’**. Since the onset of the National AIDS Control Programme, it has been observed that the community which was marginalized through their relentless efforts, found a space in terms of their rights to health and against stigma and discrimination. NACO takes keen interest in understanding and responding to the health needs of the community. Through these examples, NACO empathetically

states itself to be the fulcrum of the vulnerables. The long- term association with USAID in India under the PEPFAR umbrella, with JHU/ACCELERATE

team was appreciated for the successful development of the movie, from conceptualization to execution under the guidance of NACO.

Community System Strengthening- For, With & By the Community

A National Stakeholder Consultation was conducted by National AIDS Control Organization in Bhopal under the chairpersonship of **Ms. Nidhi Kesarwani, Director, NACO**. The objective of the consultation was to gather information on specific needs and priority areas to be included in the modules as well as to build consensus on other essential components under Community System Strengthening namely: Community Championship Program, Constitution of Community Resource Group at district and State level and lastly on the CSS National Guidance document for India.

Various stakeholders shared global and national experiences on implementing Community System Strengthening. The consultation brought forward the focus of CSS, which has been towards achieving outcomes in both the domains of prevention and treatment. It was reiterated by Director, NACO that CSS under NACP, will lead to progress on the front of universal access to health care and realizing the rights of everyone to achieve the highest attainable standards of health, no matter who they are or where they live.



2nd National LGBTQI+ symposium

At the 2nd National LGBTQI+ symposium, **Shri Alok Saxena, AS & DG, NACO** elaborated on addressing the needs of the LGBTQI+ community and the formulation of services. He emphasized that training needs to be undertaken for the medical practitioners and health researchers for the same. Cutting edge research on community issues and involving the community is a mandate to develop this.



NACO being a major stakeholder is actively taking part in reviewing the medical curriculum and aims to establish a center at AIIMS for community

centered needs. It was advised to build coalition with education centers for the mental well-being of community.

Consolidation and Roll Out of the Sampoorna Suraksha Strategy (SSS)



India has reached a critical junction requiring concerted efforts to attain 95-95-95 targets by 2025 and ultimately achieve the goal of ending the HIV epidemic by 2030. To achieve this ambitious goal, intensified preventive efforts are needed to accelerate reduction in new infections and avert AIDS-related deaths at much higher rate. In order to reach out to the population “At Risk” for HIV and STIs with a comprehensive preventive services delivery package, NACO has envisaged a new form of “Immersion Learning Model” of Service delivery as ‘**Sampoorna Suraksha Strategy**’. This initiative is planned under Global Fund Grant 2021-24 with the goal of arresting the spread of HIV among ‘At Risk’ HIV negative population by effectively targeting and tailoring interventions to prevent HIV transmission.

Sampoorna Suraksha Strategy (SSS) will enable wider outreach and service delivery models to prevent HIV infections in locations and population groups that are “At Risk” for HIV and STIs and are affected by the epidemic i.e. HRG Population not associated with Targeted Intervention Project or those who are operating through virtual platforms will be covered with differentiated approach by providing them the comprehensive services package in a stigma free environment.

The event ‘**Consolidation and Roll Out of the Sampoorna Suraksha Strategy (SSS)**’ was organized on 14th and 15th Dec. 2021 at New Delhi to roll out the programme in the field. Implementation will start off with 10 districts of 3 States i.e Gujarat, Punjab and Telangana a Pilot by March 2022, followed by 65 districts of 10 States in the year 2022-23 in first phase and another 75 districts of additional 10 States in phase II. In total, 150 SSS Sites are planned in 20 States till the year 2024.

During the programme, the overview of SSS and the work done so far under Sampoorna Suraksha Strategy was shared with the participants. A draft Guidance Note has been developed to serve as a guiding document for State AIDS Control Societies (SACS) to develop the implementation plan of SSS in their respective States. It also details out the roll out activities with the aim of emersion learning to help in developing the strategy and which will keep evolving based on field experiences.

Additional Secretary & Director General - NACO, Sh. Alok Saxena released the Sampoorna Suraksha Strategy “**Consultation Report**” (held on 12th-13th August, 2021) along with the **Draft of “Guidance Note”** and “**the Logo**” of SSS.

Supportive Supervision visit to Rajasthan to Strengthen NACP activities



Ms. Nidhi Kesarwani, Director, NACO visited Rajasthan along with senior officials to review NACP activity. NACO team visited NACP facilities located in JLN Medical College & Hospital campus in Ajmer city and reviewed Targeted Intervention project implemented for Injecting Drug Users. Key issues related to opening of Opioid Substitution Therapy (OST), quality of counseling

in ICTC/DSRC, Anti-Retroviral Therapy (ART) were discussed. Emphasis was laid upon reaching out to 'At Risk' population with prevention and treatment services, provision of social security to the key vulnerable population, optimization of resources, and ensuring regular field visits by SACS official to the NACP facilities etc.

Gender Affirmative Care (GAC) Center for Transgender people

The National Human Rights Commission in India has recommended for creating enabling environment and increase the access of health care facilities for Transgender community. Taking cognizance of the issues relating to the rights of LGBTQI community and considering the demand of the community, a pilot intervention of establishing a Gender Affirmative Care (GAC) was initiated under the chairpersonship of Ms. Nidhi Kesarwani, Director NACO. It was discussed that, the training module may also be developed for the medical practitioners for different specialties to deal with the Transgender community. During this meeting, representatives from AIIMS-New Delhi, WPATH organization, NACO representatives, CEO

of ATHI organization & various community experts actively participated and discussed about the global practices of sex reassignment surgeries among participants and the health needs of the transgender community.



National Workshop on 'Strengthening Mainstreaming Efforts in NACP'

A two-day National Workshop for the Mainstreaming and GIPA officers from State AIDS Control Societies on 'Strengthening mainstreaming efforts in NACP' was held on 16th & 17th December, 2021 at New Delhi. The objective of the workshop was to build the capacity of the participants to strengthen Advocacy, Mainstreaming efforts and upscale Social Protection at the States/UTs.

The workshop was inaugurated by Shri Alok Saxena, Additional Secretary & Director General, NACO. The inaugural event was also graced by the presence of Smt. Radhika Chakravarthy, Joint Secretary, Dept. of Social Justice & Empowerment (DoSJE) and Ms. Nidhi Kesarwani, Director, NACO and officials from NACO. Officials from ministries namely Department of Internal Security; Department of Defence; Employees' State Insurance Corporation (ESIC), Ministry of Labour & Employment; Coal India Limited; BEST, Mumbai and representatives from UNAIDS; UNDP; CDC; USAID and positive network also attended the event.

In his address, AS & DG, NACO remarked a multi-sectoral approach is required and synergy need to be built with other programmes to ensure that we reach out to each and every person exposed to HIV, further link them with the services and provide social protection benefits to people affected and infected with HIV. Smt. Radhika Chakravarthy, Joint Secretary, DoSJE, highlighted that converging activities of DoSJE and NACO will help in sensitizing and reaching out to large number of youths and women.

Experts from UNDP, ILO, World Health Partners, Plan India, Public Sector Undertakings and Private Sector were invited to take various sessions in the workshop. During the workshop, Ms. Nadia Rasheed, Deputy Resident Representative, UNDP also addressed the participants and lauded the mainstreaming efforts of NACO in achieving the SDG. The two-day workshop provided an opportunity to learn the best practices, experiences from each other and newer approaches from the speakers.



Regional Review meetings of IEC, Youth and Mainstreaming

Three regional level review meetings of IEC Youth & Mainstreaming division were organized at Chhattisgarh, Assam and Rajasthan in the Month of November & December 2021. Joint Director (IEC), Assistant Director (Youth), Deputy Director (Social Protection Scheme) and Assistant Director (GIPA) of respective SACS attended the review meeting from each State. New interventions to strengthen the IEC were discussed and the participating State teams brainstormed for developing the roadmap for 2022-23. Best practices

from each State were showcased to be piloted and scaled up. Besides the expenditure component, review meetings also paved way for scaling up of best practices. Each State teams was encouraged to strengthen their social media handles and engage youth in an effective way. SACS were encouraged to strengthen their mainstreaming activities and to build synergies with the line departments to promote services and social protection.



National AIDS Control Organisation successfully launches 3 Phases of *Azadi ka Amrit Mahotsav*

NACO successfully completed three major awareness campaigns on HIV/AIDS, Tuberculosis and Voluntary Blood Donation to celebrate and commemorate 75 years of progressive India and the glorious history of its people, culture and achievements. The event aimed at using the potential of the youth of India towards spreading awareness about HIV, TB and Voluntary Blood Donation across the nation. The 1st phase of the campaign was launched on 12th August, 2021 on the International Youth Day by Dr. Mansukh Mandaviya, Hon'ble Union Minister of Health & Family Welfare. The event was virtually joined by more than 1,23,000 students from different schools and colleges across the country. The 2nd phase of the campaign
