In consideration of the recommendation of the Odisha State Council on AIDS and the proposal of the Ministry of Road Transport & Highways, Govt. of India to make a suitable provision of free transport to the persons living with HIV/AIDS for their journey to the ART Centres for prevention and control of HIV/AIDS, the Government of Odisha, after due consideration, have been pleased to allow free travel to persons with Immune Deficiency (HIV/AIDS) while travelling in the Government & Private stage carriages operating in the State.

2. Such concession shall be made available on production of Identity Card/Medical Certificate from the Competent Authority, i.e. State AIDS Cell, in support of such claim.

Ordered that the Resolution be published in the Extra Ordinary issue of the Odisha Gazette.

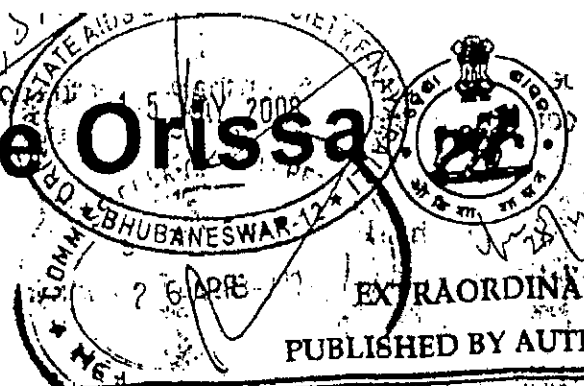

RESOLUTION

The State Government after careful consideration have been pleased to make the following amendments to the Rule 6(a)(v), 6(a)(vi), 6(b), 8, 9(b), 9(d), 12, 15 and the Application Form (MBPY-I) of the Madhu Babu Pension Yojana Rules, 2008 issued vide Women & Child Development Department Resolution No. I-SD-50/2007-11-SWCD., dated the 4th January 2008.

AMENDMENT

1. For the existing Rule 6(a)(v), the following shall be substituted—

[or, a widow of HIV positive person (irrespective of age and income criteria mentioned under Rule 6 (b).)] (WP-AIDS).

1.2. For the existing Rule 6(a)(vi), the following shall be substituted—

[or, a HIV positive person identified by the Orissa State AIDS Control Society (irrespective of age and income criteria as under Rule 6 (b).)] (DP-AIDS).

1.3. For the existing Rule 6(b), the following shall be substituted, has family income from all sources not exceeding Rs. 12,000 (Rupees twelve thousand) per annum. or, included in the BPL List.

1.4. To the existing Rule 8, the following shall be added (g) Pension due to HIV positive persons will be remitted by the B.D.O. concerned in shape of Account Payee Cheques by post to the pensioner at his/her residential address every month.

1.5. To the existing Rule 9(b), the following shall be added, "No application is required to be made for the DP-AIDS".

1.6. From the list of documents mentioned under Rule 9(b), the documents at (i), (ii), (iii) and (vi) shall be deleted.

1.7. To the existing Rule 9(d) the following shall be added :

"In the cases where the applicants are not in the BPL list, the Extension Officer shall

collect information from the Revenue Inspector concerned on the body of the application itself regarding annual family income of the applicant before forwarding it to the BDO."

1.8. To the existing Rule 12, the following shall be added:

Procedure for selection and disbursement of Madhu Babu Pension in respect of DP-AIDS and WP-AIDS.

(i) As per the existing procedure of identification of HIV patients, the Block level ICT Centres will send the names of the HIV positive patients to the "Orissa State AIDS Control Society(OSACS)". OSACS will send the list of the patients with detail address and copies of the certificates of the Medical Officers to the concerned Collectors of the district.

(ii) The District Collector on receipt of such intimation from the OSACS, will sanction Madhu Babu Pension as a measure of social security and send copy of the sanction order to the concerned Block Development Officer, Medical Officer of ICTC concerned, OSACS and also to the person concerned.

(iii) After sanction of benefits, funds may be placed by the Collector with the B.D.O. who will send the amount in shape of Account Payee Cheque in the name of the concerned HIV positive person to his/her residential address.

(iv) As regards the widows of the HIV positive cases, OSACS will send the names of persons who have died because of AIDS to the Collectors. Collectors will first check up at their level if the widows of the HIV positive deceased person is also HIV positive, in such cases, Collector will sanction DP-AIDS category of Madhu Babu Pension for the widow of the HIV case.

(v) Further, in case she is not HIV positive herself, then local enquiry should be done through the B.D.O. and widow pension should be sanctioned for such cases on priority as per the regular procedure for sanction of Madhu Babu Pension, i.e. the Sub-Collector will be the sanctioning authority for the widow pension for widows of the HIV positive cases. Disbursement of pension to such beneficiaries will also be done as per the regular procedure of disbursement of Madhu Babu Pension.

1.9. To the existing Rule 15, the following shall be added, "No photo Identity Card" is necessary for the DP-AIDS category.

1.10. The application Form for "Madhu Babu Pension"(MBPY-I) has been revised for simplicity of the applicant:

Sub: Implementation of the State Plan Scheme "Mo Kudia" during the year 2009-10.

Sir/Madam,

The State Government have launched "Mo Kudia" (My House) scheme from the year 2008-09 to meet the un-mate need of the most vulnerable house holds who need immediate shelter for dignified existence. The procedural bottleneck for the following IAY pattern creates avoidable problem in instant delivery of benefits to the poor People. Government after careful consideration have been pleased to modify the guidelines under "Mo Kudia" issued earlier to take care of delay and resultant neglect of the deserving beneficiaries.

The amount of assistance for each unit of approximately 20 sq. mtr. House including toilet shall be Rs.35,000/- (same as IAY) and confined to low income group if listed under BPL. The rural households whose name does not find place in the BPL list but are otherwise genuine poor may also be allotted a house in the joint name of spouse with preference to following:

- ♦ The poor women in distress, physically challenged (over 40%), mentally challenged, victims of domestic violence; destitute widows, women-headed households, adult orphans of government registered institution, victims of leprosy and AIDs will be eligible to get a house.
- ♦ The poor victims of ethnic and sexual violence may be considered on priority.
- ♦ The poor victims of fire or flood can be considered.
- ♦ The tribal households whose houses are "fully collapsed" due to elephant menace can be considered.
- ♦ The Flood damage assistance of Rs.10,000/- may be tagged with Mo Kudia for "fully collapsed" category.
- ♦ The primitive tribes groups (PTG) may be given priority without insisting on title of land.
- ♦ The list of beneficiaries shall be placed before Panch Sabha for information to avoid duplication and better targeting.
- ♦ Mo Kudia may also be linked with Mo Diha (My Homestead Land) in case of SC and ST persons.
