Under the TPDS rules all BPL HIV families are to be included in the category of AAY families.





NOTIFICATION

In accordance with Section 16 of the Sikkim Nationalized Transport (Prevention of Ticketless Travel & Miscellaneous Provisions) Act, 1981 the State Government is pleased to announce that all the People Living with HIV/AIDS (PLHAs) in the State shall be allowed to travel free of charge upto a maximum of 2(two) round trips in one month throughout the State and upto Siliguri in all buses operated by the Transport Department (SNT Division) barring AC Deluxe and Super Deluxe buses.

In order to avail of this benefit, the PLHAs must, at the time of travel, be in possession of the "Special Identity Card" issued by the SNT Division of Transport Department, Government of Sikkim.

This order will come into force with immediate effect.
