Please find enclosed copy of the list of HIV/AIDS patients under BPL category which is sent by the Project Director, Tripura State AIDS Control Society (SACS) vide his communication No. F. 3(9-4)/ART/TSACS/2007-08/Sub-1/11770 dated 20th March, 2010. It has been informed that the names of the enlisted HIV/AIDS patients under BPL category have been registered at ART Centre, AGMC & GBP Hospital for treatment. In this regard, keeping in view the Order of the Hon'ble Supreme Court in a PIL case, Writ Petition (Civil) No. 535/ 1998 passed on 26-03-2009 and provisions in the existing AAY guidelines, all concerned are further requested to review the existing list of AAY families of HIV positive persons in the AAY list, delete ineligible AAY families therefrom and include all eligible BPL families of HIV positive persons in the AAY list on priority within the respective ceilings on numbers of AAY families as fixed by the Government of India.

2. Accordingly, all Sub-Divisional Magistrate(s) are requested to take necessary action in the above procedure and confirm this Office about the action(s) as taken in regard to the above list of HIV/AIDS patients.

Sub: Providing facility of free travel to HIV/AIDS infected people.


Sir,



2. This will take with immediate effect.


